PUBLIC QUESTIONS TO BE VOTED UPON

QUESTION NO. 1

Shall the Board of Fire Commissioners of Fire District No. 1 in Toms River Township be authorized to budget \$9,032,603.00 in the year 2018 with \$5,497,530.23 to be raised by taxation?

INTERPRETATIVE STATEMENT

Approval of this question would authorize Toms River Fire District No. 1 to budget \$9,032,603.00 for the operation of the Fire District. The amount raised by taxation only represents a portion of the budget. The remaining revenue comes from District No. 2 for shared costs in operating the Bureau of Fire Prevention, Fire Communication Center and the Fire Training Center: from inspection fees; usage fees; from interest earned on investments; from grants; and from surplus.

QUESTION NO. 2

Shall the Board of Fire Commissioners of Fire District No. 1 in Toms River Township be authorized to appropriate \$450,000.00 for the purchase of replacement fire apparatus?

INTERPRETATIVE STATEMENT

Approval of this question would authorize Toms River Fire District No. 1 to budget \$450,000.00 for the purchase of fire apparatus. The Board of Fire Commissioners determines the timing of the replacement fire apparatus in accordance with National Standards. The Board also takes into account maintenance costs. The Board annually asks the voters to approve setting aside a portion of the entire replacement cost in order to prevent incurring additional costs associated with bonding for these purchases. This procedure also limits fluctuations in the tax rate from year to year. The annual amount submitted to voter approval is based on estimated replacement costs of apparatus nearing the end of its life expectancy or apparatus with excessive maintenance costs.

Approval of this question would authorize Toms River Fire District No. 1 to appropriate \$55,040.00 for the purchase of replacement vehicles to be used by the Bureau of Fire Prevention. The Board of Fire Commissioners operates the Fire Bureau in conjunction with District No. 2. The amount represents District No. 1 proportional share of the cost. The Board determines the timing of replacement vehicles utilized by the Bureau based upon the age, mileage and maintenance costs of the vehicles. The share of expenses between the two districts is based upon the tax base of the two districts.
