The amount raised by taxation only represents a portion of the budget. The remaining revenue comes from District No. 2 for shared costs in operating the Bureau of Fire Prevention, Fire Communication Center and the Fire Training Center; from inspection fees; usage fees; from interest earned on investments; from grants; and from surplus.</p>

The Board of Fire Commissioners operates in conjunction with Fire District No. 2 the Toms River Fire Training Center. Toms River Board of Fire Commissioners District No. 2 will reimburse the Toms River Board of Fire Commissioners District No. 1 in the amount of \$36,000.00 for their share of the cost of these upgrades. In order to maintain and upgrade that facility, the Board seeks authority for its share of the expense.
